WHAT WE ARE / ARE NOT

- Azul Montana is an Orlando NARR Level 2 substance-free supportive recovery residence.
- We provide supportive housing only. We are NOT treatment, detox, clinical care, medication management, assisted living, or an emergency shelter.
- Residents are licensees, not tenants, under a written Bed License Agreement.

WHO WE SERVE

- Adults seeking structured, substance-free supportive housing in the Orlando metro.
- People able to follow written house standards and participate in shared living.
- Residents connected with outside recovery, employment, court, case-management, or community supports as appropriate.

HOUSE MODEL

- Standardized 4-5 bedroom / 2-3 bath homes.
- Maximum 2 beds per room; 8-10 beds per house.
- Arrival support may be available for property move-in, agency check-ins, and transition-out planning.

INTAKE CRITERIA

- High-level fit review for recovery housing readiness, safety, house compatibility, and ability to follow expectations.
- Initial outreach should include only basic contact information and non-PHI placement-fit or availability questions.
- Please do not send Social Security Numbers, diagnoses, medication lists, criminal history, or other sensitive personal information in the first inquiry.

COMPLIANCE SNAPSHOT

- No referral fees, commissions, gifts, split fees, or other inducements are offered or accepted.
- Florida Patient Brokering Act compliant; housing charge is not a referral fee or inducement.
- Pursuing FARR certification under Fla. Stat. 397.487; Azul Montana is not currently FARR-certified.
- One-time non-refundable \$250 move-in fee is disclosed in writing before funds are accepted.
